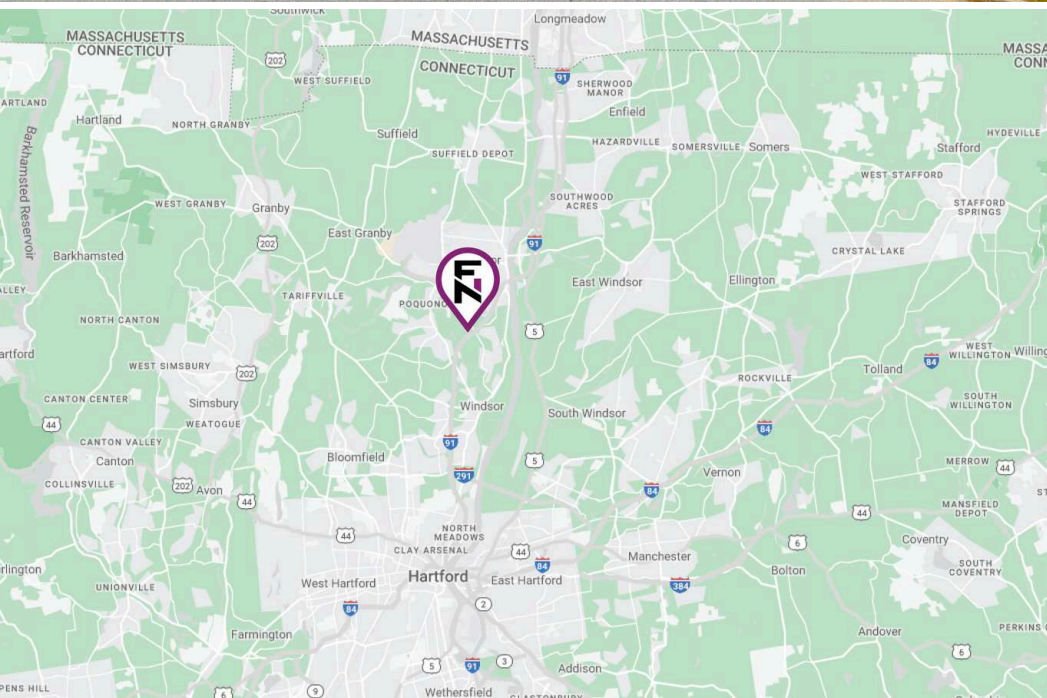

- Within a 5-mile radius, the population is over 53,000 people and the average household income is over \$121,000.



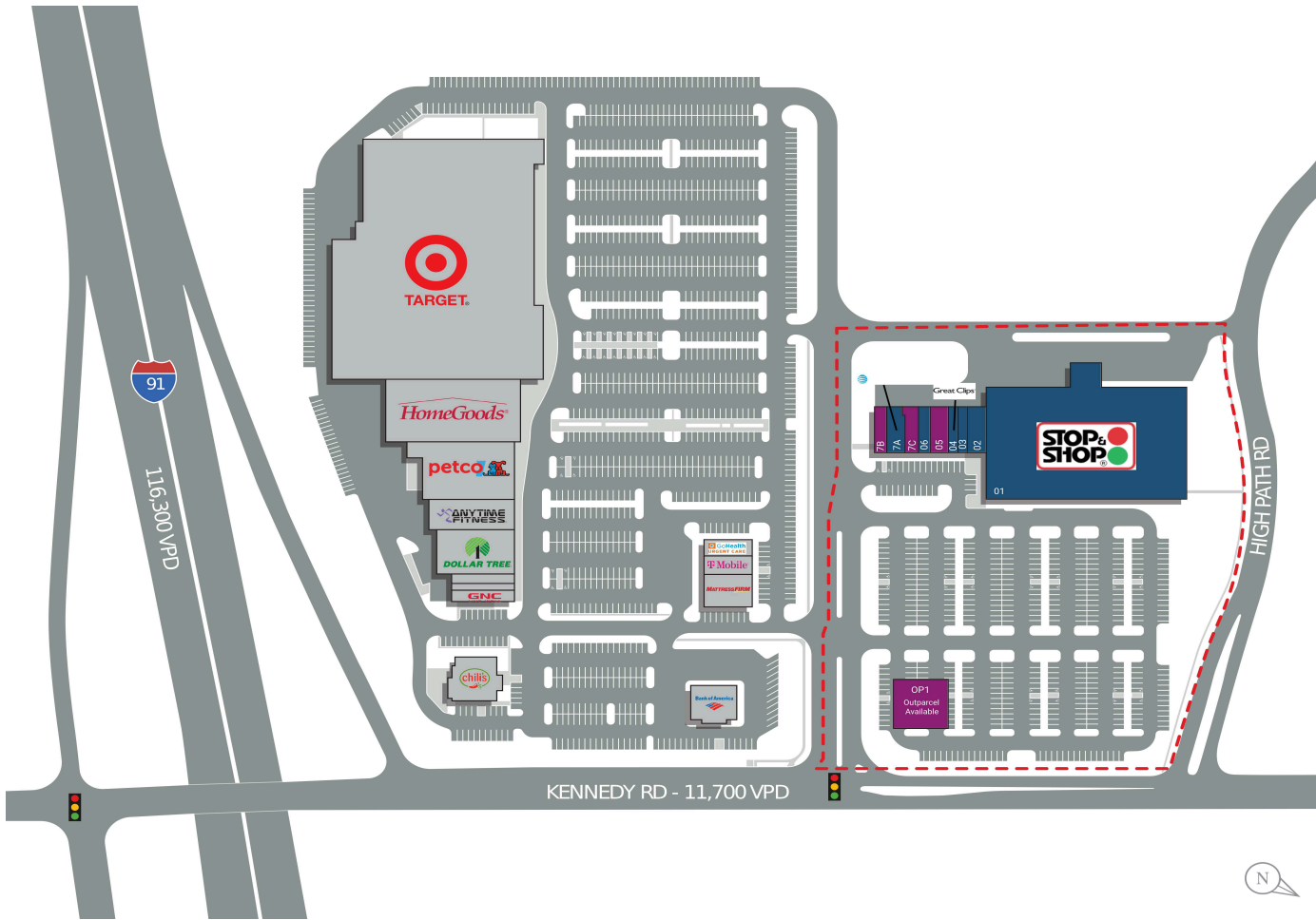
